#### **"DOING BUSINESS WITH SOCIAL SECURITY ONLINE AT SOCIALSECURITY.GOV"**

As Americans become increasingly comfortable with the security and convenience of doing things on the Internet, online business is becoming more and more popular. In addition to preplanning your retirement, there are a number of other conveniences. For example:

Use the disability and survivors planners to find out how much you or your family might qualify for if the need arises. www.socialsecurity.gov/planners

Benefit Verification! Social Security makes it easy for you to get the written verification you need at <u>www.socialsecurity.gov</u>. This site can help verify your Medicare coverage, retirement or disability status, and age.

Whether you're interested in retirement benefits, disability, survivor's benefits, learning about Social Security's history or finding out about how the system works, the online website is the most convenient one to visit.

#### In Your Time of Need Social Security Can Help – Survivors Benefits Explained

The loss of a loved one can be painful. The death of a wage-earner upon whom a family depends also can be financially devastating.

If you're like most young or middle-aged workers, you probably think of Social Security only as a retirement program. However, some of the Social Security taxes you pay go toward providing survivors insurance for workers and their families. Think of it as a life insurance policy you never knew you had — paid for by the same taxes that cover you for retirement or disability.

When you die, certain members of your family may be eligible for survivor's benefits. These include widows, widowers, children, and even dependent parents. In many cases, there also is a one-time lump-sum payment of \$255 that can be made to a surviving spouse or minor children who meet certain requirements.

You may not think it will happen to you, but the stunning truth is that one in eight of today's 20-year-olds will die before reaching their full retirement age of 67. In fact, 98 of every 100 children could get benefits if a working parent dies. More than 6.4 million survivors receive benefits. The average Survivors' benefit is \$1,140 a month.

It is also important to remember that we pay divorced widows and widowers. If you are unmarried or remarried after age 60 and had a marriage that lasted over 10 years then ended in divorce, you could qualify for benefits. Many divorced spouse don't even know their former spouse has passed on and could be giving up hundreds of dollars each month.

If you are a survivor, you should apply for survivors' benefit right away. You can apply by telephone or at any Social Security office. Call us toll-free at **1-800-772-1213** (TTY: **1-800-325-0778).** To help prepare you, here is the information we will need:

- Proof of death either from a funeral home or a death certificate;
- Your Social Security number, as well as the deceased worker's;
- Your birth certificate;
- Your marriage certificate, if you are a widow or widower;

Your divorce papers, if you are applying as a divorced widow or widower;

# Question:

If both my spouse and I are entitled to Social Security benefits, is there any reduction in our payments because we are married?

#### Answer:

No. We independently calculate each spouse's Social Security benefit amount. Each spouse receives a monthly benefit amount based on his or her own earnings. Couples are not penalized simply because they are married. If one member of the couple earned low wages or did not earn enough Social Security credits to be eligible for retirement benefits, he or she may be eligible to receive benefits as a spouse.

## Question:

Do I have to pay income tax on my Social Security benefits?

# Answer:

It depends. Fewer than one-third of our current beneficiaries pay income taxes on their benefits. You will have to pay Federal income taxes on your benefits if you file an individual Federal income tax return and your total income is more than \$25,000. If you file a joint return, you will have to pay income taxes if you and your spouse have total income of more than \$32,000.

#### 4. Habitat for Humanity Volunteer Opportunity

My name is Dick Gram and I started my volunteer efforts with the East King County Habitat affiliate in 1999 at their Newcastle site. Since finishing the 12 condominiums there I've had the opportunity to work at the Redmond site (24 condominiums), Snoqualmie Ridge (50 homes), and Issaquah Highlands (10 duplexes including 2 still under construction). The affiliate has also collaborated with Habitat of Seattle to acquire property in Renton where construction on 43 condominiums is underway. The affiliate's vision is "to make it possible for all residents of East King County to live in simple, decent, affordable housing through homeownership." They have an excellent homeowner selection process which looks at families that currently have an income of 50% or less of the median East King County income, a willingness to partner with Habitat EKC, and good credit. Families are required to provide 500 hours of "sweat equity" as part of their qualification process which represents the downpayment on their home.

There are many ways to get involved with Habitat. Volunteer opportunities can be found in the Habitat office, at the recently opened Habitat Restore in Bellevue, and at the jobsite(s). If you choose to work at the jobsite (my choice), prior construction experience is not required. While you may bring your own tools, that's not required as Habitat has plenty of tools onsite. You'll find the opportunity to work alongside future homeowner families rewarding and enlightening. If you're like me you'll acquire new skills for your own home projects. Since Habitat's volunteers are most needed during the week as a retiree you'll be in high demand. If you'd like to take your building "skills" to another country you'll have that opportunity as the Habitat EKC affiliate has at least two global builds a year for which you can volunteer. If you want to get more involved in the planning or fundraising activities of the affiliate, opportunities on the Habitat board or advisory board may be your thing. Habitat also reaches out to other non-profits as evidenced by their recent refurbishment of shelters for victims of domestic violence which may be of interest to you as well.

I've found my 13 year involvement with Habitat to be extremely rewarding. If it appeals to you, give it a try and I'm certain you'll experience the same result.
